PERSONALIZED WORK FLOW: CUSTOM MENUS, TEMPLATES, AND ADVANCED WORD PROCESSOR

We provide a standard set of templates and forms for each specialty, but each physician may create custom templates with text boxes, pull down menus, check boxes, yes/no menus, and tables. Each template is assigned to a form and are automatically selected based on visit type, specialty, location, and physician. Information from vitals, prescriptions, diagnosis, HPI, orders, and custom templates can be automatically inserted into a note. Our advanced word processor is used to make modifications, insert images, add tables, customize letterhead, and sign notes. Addendums are also supported.

CARE MANAGEMENT & QUALITY MEASURES

Custom decision support and care maintenance rules can be added to provide alerts and send notifications to patients via the Enablemyhealth portal or letters. These same rules can be used for quality measure tracking. All meaningful use rules are setup in the system for ease of management and reporting. PQRS and ACO measures can also be tracked and reported through the system.

CLAIMS & COLLECTIONS MANAGEMENT

EnableDoc's billing module operates both with or without the EHR module to expedite claims processing and payments collection. Physician groups are able to create payer claims, print HCFA 1500 forms, electronically send claims via any clearinghouse, print or send patient statements, and manage the entire collections process. Collections are easily categorized and assigned to employees. Advanced management tools enable detailed filtering of medical claims, denials, collections, and account receivable information. A complete set of financial reports are also provided. Claim and collection notes can be made with each collection activity or status change. A billing dashboard displays key information on monthly, annual, and year-to-date financial criteria for daily financial management.

ENABLING FEFICIENT COMMUNICATIONS





Orders may be placed for labs, images, procedures, and all other services by easily searching through a coded services database or by selecting from past or favorite orders.




Prescriptions are written by selecting medications based on brand or generic name, diagnosis, past medications, or favorite medications. Dosage is automatically calculated based on patient gender, age, weight, and BSA. Physicians are alerted to interactions based on drug, allergy, condition, and foods taken. Prescriptions may be sent electronically via the Surescripts® Network, faxed, or printed.




FRONT DESK MANAGEMENT

ELECTRONIC HEALTH RECORD MANAGEMENT
